2008 Traveling Soccer General Information and Registration

Player registration is accepted on in-person sign-up days or by mail. Registration by mail may be sent to Kim Brinkoetter, 8410 90th St S. Cottage Grove MN 55016. You must include a completed registration form, payment as described below, and, if required, a copy of your son/daughter's birth certificate (birth certificate is required for all first-time traveling players). The registration will NOT be processed or accepted without these required items.

The 2008 fall registration fee is \$100.00 for new players and \$75.00 for returning players if no uniform is needed. Your uniform must be in GOOD condition. Additional costs may be incurred based upon team and/or coach's discretion (tournaments, warm-ups, etc.) Each player will be responsible for his or her share of the additional expenses. Any past due amounts from the spring 2008 season must be paid in full or registration for the 2008 season will not be accepted for any family member.

ALL payments are due at the time of sign-up. There are no refunds once a player is placed on a team. Please contact Patti Diamond, Treasurer at 651-458-2975 for further information and for any payment questions.
